There was no objection from Council regarding the appointments.

COMMITTEE REPORTS:

Parks Director Noah Flores reported that the Tree Board and he attended the Tree City USA Recognition Day in Derby on March 28 marking Lindsborg's 39th year as a Tree City U.S.A.

To be recognized as a Tree City U.S.A., cities must meet four requirements: maintain a Tree Board, have a community tree ordinance, spend at least \$2 per capita on our urban forestry, and celebrate Arbor Day.

While there, they saw the annual Kansas Forest Service poster contest. A poster from Soderstrom Elementary was chosen as the regional winner for the South-Central region. Flores is currently working on an event to celebrate the winner.

Community Development Director Milton Collins reported that the Planning Commission met on March 26 and approved three lot splits, two of which were at Stockholm Estates. The Design Review Board met on March 18 and reviewed three signs: Bella Sol Bistro, Smoky Valley Bakery, and the Good Merchant. All signs were approved. Design Review also reviewed and approved the proposed façade for the Good Merchant, which was a recipient of the HEAL Grant (Historic Economic Asset Lifeline).

OLD BUSINESS:

There was no old business.

NEW BUSINESS:

Golf Cart Renewal

The City of Lindsborg Golf Course has a six-year lease for 10 RXV Elite Lithium-ion battery golf carts, good through May of 2025. This lease is with Kansas Golf & Turf (KG&T) in Wichita, Kansas.

The carts are almond color with fold-down windshield, cooler and bracket attached, USB ports, wheel covers, message holder, and premium seats (high back and custom). These carts are energy efficient--guaranteed 30% less energy used and up to a possibility of 50%.

The amount due for each year (\$10,879.20) for all 10 carts is encumbered and paid at a rate of \$906.60/month.

Councilmember Joshua Swanson moved to approve the lease of 10 golf carts for the Lindsborg Golf Course at a cost of \$10,879.20 with Kansas Golf & Turf for the 2024 season. Seconded by Councilmember Andrew Smith and passed 6-0 by roll call vote.

ADJOURNMENT:

Councilmember Kirsten Bruce moved for adjournment, seconded by Councilmember Blaine Heble, and passed 6-0 by voice vote. The meeting was adjourned at 6:48 p.m.
