MAYOR'S REPORT:

Mayor Shultz thanked CVB Director Holly Lofton for all of her work organizing the City of Lindsborg booth at the Kansas State Fair. He also thanked the many volunteers who staffed the booth.

Mayor Shultz shared the Councilmember John Presley won 1st in class, 2nd in People's Choice and Best of Show for his carving.

The Soderstrom third graders came to city hall and this past week and heard from all of the department directors and also had a chance to explore the "big trucks" from the city.

A notice of public hearing for the McPherson County Board of Planning and Zoning was shared with Council. The purpose of the hearing is the adoption of a comprehensive plan.

Mayor Shultz also expressed his condolences to the families of Dan Gottneid and Lisa Christopher.

CONSENT AGENDA

Councilmember Kirsten Bruce moved to approve the minutes from the September 2, 2025, regular Council meeting, Payroll Ordinance 5554 and Purchase Order Ordinance 5555. Motion seconded by Councilmember Joshua Swanson and passed 7-0 by roll call vote.

APPOINTMENTS:

Mayor Clark Shultz appointed Alex Osmun to the Lindsborg Volunteer Fire Department.

COMMITTEE REPORTS:

Community Development Director Milton Collins shared that the Board of Zoning Appeals (BZA) met and heard a request from the Smorgasbord Chairs of the Hyllningsfest Committee. They asked to have digital signage in the window of the Sundstrom during the festival. The digital signage would advertise ticket sales as well as the menu. The request was approved by BZA.

OLD BUSINESS:

There was no old business.

NEW BUSINESS:

Mixer

The biological treatment basins at the Wastewater Treatment Plant utilize a total of 8 flygt mixers for the treatment process; five of the mixers are in use 24 hours a day with the other three needed when both basins are in use.

Each unit was part of the 2010 upgrade and has been in service for 15 years. Because of the environment in which these units operate, at some point they have all had issues and needed to be sent in to be repaired or rebuilt. Staff have found that they no longer manufacture all the parts needed to repair these mixers so staff will need to go with a more current model.

JCI is the representative for Flygt and provided a quote for replacement mixers, one being an explosion proof and the other not. Staff are certain that the explosion proof mixer is not needed in the environment they are used in. The use of another brand of mixer would require the replacement of the supporting structure and possibly some reconfiguration of the electrical and electronic controls. Another brand of mixer would also require engineering work to make sure the unit would move the proper amount of liquid. Staff has been looking into whether it would make fiscal sense to budget for a complete replacement of all units in the future.

Councilmember Joshua Swanson moved to approve the purchase of a new Flygt Mixer PP4640.411 from JCI Industries for \$17,661.00. Seconded by Councilmember Blaine Heble and passed 7-0 by roll call vote.

ADJOURNMENT:

Councilmember Kirsten Bruce moved for adjournment, seconded by Councilmember Joshua Swanson, and passed 7-0 by voice vote. The meeting was adjourned at 7:06 p.m.
