RESOLUTION NO. 13-2026

A RESOLUTION AUTHORIZING A TEMPORARY EXTENSION OF PREMISES FOR OL STUGA LINDSBORG KANSAS, LLC, IN CONNECTION WITH A DESIGNATED BEER GARDEN AREA DURING THE STREET DANCE EVENT ON SEPTEMBER 26, 2026.

WHEREAS, Ol Stuga Lindsborg Kansas, LLC ("Ol Stuga"), is a business located within the City of Lindsborg and is duly licensed by the State of Kansas to sell and serve alcoholic liquor and cereal malt beverages; and

WHEREAS, Ol Stuga has requested approval for a temporary extension of its licensed premises in conjunction with the Street Dance event to be held on September 26, 2026; and

WHEREAS, the proposed temporary extension would extend west from the front entrance of Ol Stuga and encompass designated portions of the adjoining City sidewalk and Main Street to be utilized as a controlled beer garden area; and

WHEREAS, Ol Stuga will be responsible for the operation, staffing, access control, identification verification, and regulatory compliance within the designated beer garden area; and

WHEREAS, the City Council of the City of Lindsborg finds that the requested temporary extension of premises will serve the public interest and support a community event while providing for the orderly and safe service of alcoholic beverages.

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF LINDSBORG, KANSAS:

Section 1. The City Council hereby approves the temporary extension of the licensed premises of Ol Stuga Lindsborg Kansas, LLC, for September 26, 2026, in connection with the Street Dance event.

Section 2. The approved extension of premises shall extend west from the front entrance of Ol Stuga and include designated portions of the adjoining City sidewalk and Main Street as identified and approved by City staff and applicable state regulatory authorities for use as a beer garden.

Section 3. Ol Stuga shall be responsible for maintaining all required licenses, permits, barriers, security measures, identification checks, and compliance with all applicable federal, state, and local laws and regulations governing the sale and consumption of alcoholic beverages.

Section 4. This authorization is limited to September 26, 2026, and the approved hours of operation for the beer garden shall be from 4:00 p.m. until 11:59 p.m., unless otherwise authorized by law or permit.

Section 5. The City Clerk is authorized to provide a certified copy of this Resolution as may be required for submission to the State of Kansas and related licensing authorities.

SUMMARY of RESOLUTION for PUBLICATION

On August 17, 2026, the Governing Body of the City of Lindsborg, Kansas, adopted Resolution No. 13-2026 authorizing a temporary extension of the licensed premises of Ol Stuga Lindsborg Kansas, LLC in conjunction with the September 26, 2026, Street Dance event.

The approved extension includes designated portions of the adjoining city sidewalk and Main Street located west of the restaurant's front entrance for operation of a controlled beer garden area. The authorization is effective only for the Street Dance event on September 26, 2026, with approved operating hours from 4:00 p.m. to 11:59 p.m.

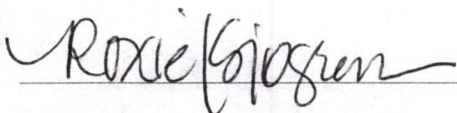

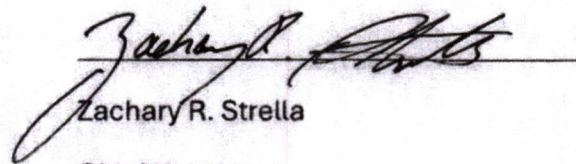
