RESOLUTION NO. 06-2025

A RESOLUTION PROVIDING FOR SUBSTITUTE IMPROVEMENTS TO BE FINANCED WITH PROCEEDS OF THE CITY OF LINDSBORG, KANSAS, GENERAL OBLIGATION REFUNDING AND IMPROVEMENT BONDS, SERIES 2016.

WHEREAS, on September 6, 2016, the City of Lindsborg, Kansas (the "Issuer"), adopted Resolution No. 13-16 (the "Bond Resolution") authorizing the issuance of the Issuer's General Obligation Refunding and Improvement Bonds, Series 2016, in the original principal amount of \$1,935,000 (the "Bonds"); and

WHEREAS, the Bond Resolution provided that the proceeds of the Bonds would finance the cost of certain public improvements (the "Improvements"), as shown below:

WHEREAS, the Bonds were issued on September 27, 2016; and

WHEREAS, Section 504 of the Bond Resolution provides that the Issuer may elect for any reason to substitute or add other improvements to be financed with proceeds of the Bonds provided certain conditions are met; and

WHEREAS, pursuant to provisions of the laws of the State of Kansas, by proceedings duly had, the governing body of the City has authorized the following improvements (the "Substitute Improvements") to be made in the City, to-wit:
